The business will use its grant to improve salon amenities, including replacing two wash basin sinks and chairs, creating a more comfortable, professional-looking experience for clients. (DBA Sir Speedy Printing) in Park Ridge provides print, signage, marketing consultation, and design services for small businesses and nonprofits such as food banks, adoption services, women's housing and the developmentally disabled. Their Accelerate Grant will be used to purchase an additional wide format printer, enabling them to expand product offerings, and improve efficiencies.
